In May 2024, the U.S. Administration for Community Living issued final regulations for Adult Protective Services. NAPSA held a memberonly call to present our analysis, share available resources, and debrief among members. NAPSA will continue to provide support to the field in understanding and interpreting the final regulations as well as bringing APS concerns to ACL. Tools to navigate and evaluate an APS program's readiness are available on the NAPSA website here.

Just to note, the comments on the notice of proposed rulemaking (NPRM) really helped reshape the Final Rule, so a huge thank you for providing your input to ensure the regulations reflect the needs of the field.



NAPSA's Gold Standards workgroup continued to meet to discuss the federal APS regulations before and after their approval. The group continued discussions on the ideal APS program and the impact of federal regulations. During 2024, the workgroup launched an effort to determine the true cost of APS. This information will help inform future comments and advocacy.

POLICY

NAPSA's Disability Advisory Group continued to meet throughout 2024 and is looking forward to conducting significant outreach in 2025! Below is the group's mission statement and four focused priority areas:

Mission: People with disabilities (PWD) will lead and inform the Adult Protective Services field on how to positively impact the lives of persons with disabilities who experience abuse, neglect, and/or exploitation.




